1. I HAVE HAD IT EXPLAINED TO ME AND UNDERSTAND THAT:

1.1 The activities undertaken at 360Mud are physically and mentally challenging and potentially dangerous, and include but are not limited to water based and other obstacles, surface hazards and run course & weather conditions;

1.2 There is a risk of serious injury and/or death associated with my participation in activities at 360Mud;

1.3 Although adherence to strict safety standards and health & safety assessments minimises these risks, they cannot be completely eliminated;
and

1.4 Participation in activities and use of facilities at 360Mud is ENTIRELY AT MY/ MY CHILDS OWN RISK.

2. I CONFIRM THAT:

2.1 I am 16 years of age or older completing this form as a parent/ guardian.

2.2 I am fully aware of the risks to myself and others associated with participation in activities and use of facilities at 360Mud. These risks include damage to or loss of personal property, personal injury and in extreme cases, death.

2.3 I will comply with all instructions given to me by the Organiser's officers, employees and volunteers and use any equipment as directed and not so as to hurt or injure others.

3.2 Nothing in this disclaimer shall be construed as limiting or excluding the Organiser's liability for:

(b) Fraudulent misrepresentation; or

(c) Any other matter for which it would be illegal or unlawful for the Organiser to exclude or attempt to exclude its liability.
